Who can enter?	<p>Only Western Australian residents who:</p> <ul style="list-style-type: none"> (a) are aged 18 or over; (b) can travel to Perth, Western Australia to take the prize to the MotorPlex Race Events between 17/04/2026 - 25/04/2026 (inclusive); (c) have an active Burson Auto Parts trade account (still active and within the terms and conditions referenced below at 11.59pm (AEST) 02/04/2026), linked to a Burson Auto Parts Store in Western Australia (Trade Account); (d) are the registered primary authorised person for the Trade Account; and (e) are a principal of the business associated with the Trade Account (Participating Business). <p>Holding a Trade Account with Burson Auto Parts (and, consequently, participation in this promotion) is subject to the terms and conditions which apply to the Trade Account (agreed to at the time of account set up), that can be found at www.burson.com.au/terms-conditions as amended from time to time.</p>

General

- 23 Without limiting the previous paragraphs, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant), due to circumstances beyond the Promoter's reasonable control.
